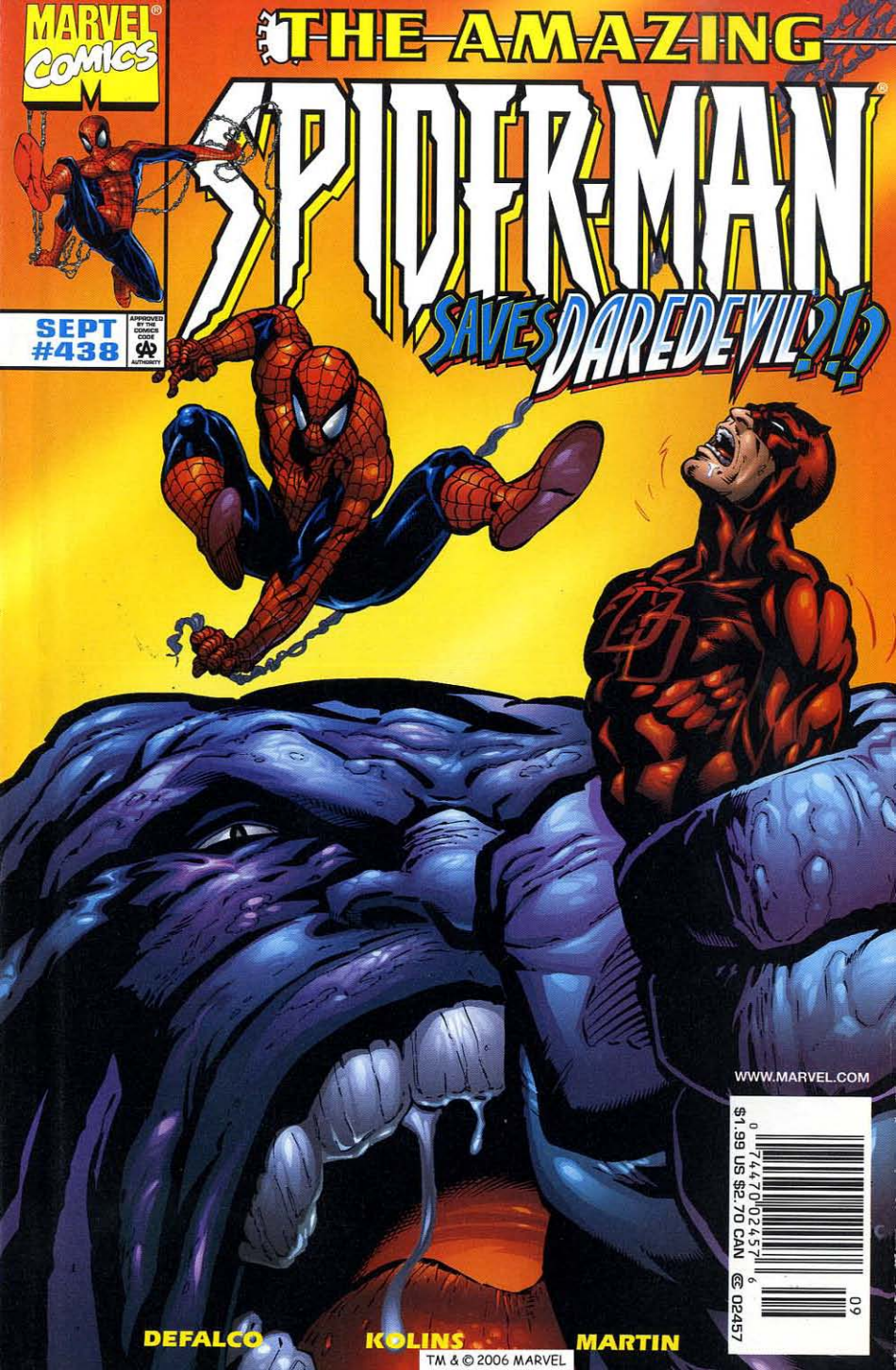

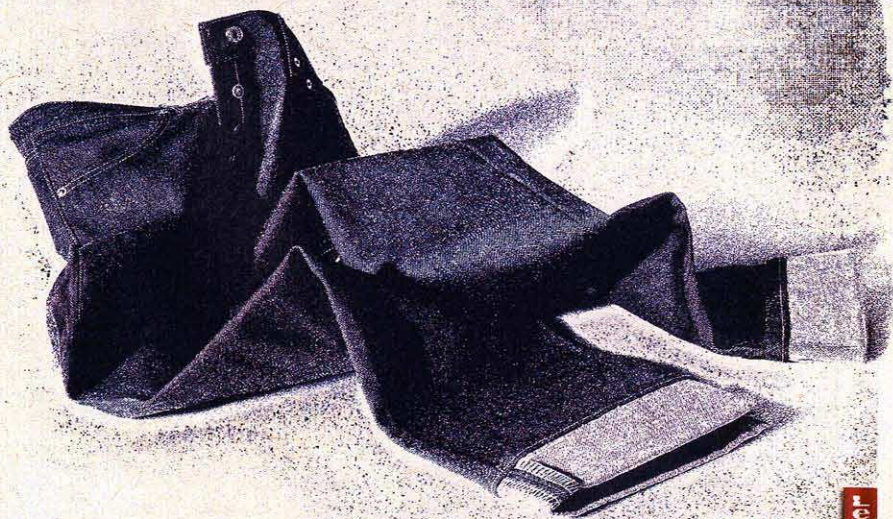
The webspinner teamed up with Generation X member, Synch, to pull the roots out from under a plundering Plantman.
